ALLOTMENT ORDER

Sub: Allotment of fund under Major Head- 2070 - Parliamentary Affairs

Now, Rs 175000/- is now allotted to DPI, WB under sub allotting menu of IFMS to organise the District Level YPC for colleges 2015-16 in Kolkata. The programme may be organised on an early date. UC need be submitted by February 2016.
