#### ALLOTMENT ORDER

Sub: Allotment of fund under Major Head- 2070 - Parliamentary Affairs for the financial Year 2015 - 2016

Sanction is hereby accorded to the allotment of fund of Rs. 2250000 (in words Rs. Twenty Two Lakh Fifty Thousand Only.) under various Heads of accounts in favour of to the Sub-Allotting Officers/DDOs as per annexure enclosed to meet the expenditure related to their own establishment and/or establishment, within their financial powers.

The fund hereby allotted and placed under the disposal of the Sub-Allotting Officers/DDOs shall not be used for any other purpose.

Rs 2250000 is allotted amongst the District Magistrates of Bankura, Jalpaiguri and North 24 Paraganas @ Rs. 7.5 lac for each District for organizing the Division Level YPC 2015-16. 50% of the amount i.e. Rs. 3.75 lac may be drawn in advance for meeting the emergent type of expenses subject to its adjustment within 60 days. U.C. needs to be submitted within 31.03.2016. This has the concurrence of Finance Department vide U.O. No. Gr N/15-16/2204 dt 30.11.2015 and Gr D/2015-2016/0493 dt 04.12.2015.

This Order is not an authority to incur any expenditure which is not permitted under West Bengal Financial Rules or any order of the State Government. Utmost Care should be taken at the time of preparation of the bill so that the accounts code as indicated against each item of expenditure along with detailed head of account are mentioned on the bill correctly.
